

BOARD MEETING

September 23, 2003

The meeting was called to order by Chairman, Mark Wilcox, at 5:10 P.M.. Mr. Wilcox introduced Grace Peters, new Lay Person, appointed to the Board to replace Larry Heck.

Minutes: Dr. Dameron made a motion to accept the minutes of June 10, 2003 as presented. Ms. Bellomy seconded the motion. Motion carried.

Financial Report: The financial report was presented by Ms. Blosser. Ms. Bellomy made a motion to accept the financial report as presented. Ms. Morris seconded the motion. Motion carried.

Complaints: (1) Technologist had her ARRT card revoked for altering her ARRT card. Mr. Bowyer advised the Board that the technologist must be offered a hearing in front of the Board before any disciplinary action could be taken. The technologist does not seem to be practicing at the present time. Mr. Bowyer was asked by the Board to contact the Boards attorney, Mr. Skinner, to draw up a letter to the technologist offering her a hearing to discuss her ARRT revoking and possible disciplinary action against her license at the December Board meeting.

- (2) Facility using LPN to do Bone Densitometry. Mr. Bowyer sent a letter to the facility and the office manager called saying they did not have a Bone Densitometry machine. Complaint dismissed.
- (3) Cardiovascular Tech performing in a Cath lab. Mr. Bowyer received the information the afternoon of the meeting and will begin an investigation. Mr. Bowyer will contact the WV Health Care Review Authority to obtain a listing of all hospitals having Cath labs and send an informational memo stating the definition of a Radiologic Technologist duties during a cath procedure. It will also state that these duties must be performed by a licensed / registered technologist, not a TA or a nurse.

Legislation: Series 1 rule passed and in effect as of June 24, 2003. Series 4 procedural rule passed and in effect as of August 15, 2003. Series 5 was passed at the June Board meeting and will now be put out for public comment.

Schools: Washburn University - Mr. Bowyer presented a survey of sixteen facilities that the Board had requested. After a short discussion the Board decided to table any further discussion until the December meeting when Ms. Christine Paugh, Radiation Therapy Technologist and Program Director could attend the meeting and discussion.

Melissa Haye, Bluefield State College, requested the Board to include something in the law regarding starting of new radiography programs in the state of WV. The Board after discussions decided the matter should be refereed to the Joint Review Committee on Education in Radiologic Technology (JRCERT), as they do not feel that is within the scope of the Board. Mr. Bowyer was asked to send Ms. Haye a letter informing her of the Board's findings.

Mountain State site visit is scheduled for November 10, and 11, 2003.

Ms Blosser informed the Board that 87 Temporary license were issued for the last graduating class with 64 passing the ARRT Examination and 4 failed.

Status of On-Line Credit Card Renewal: Mr. Bowyer explained the on-line renewal process that is used to renew a license. Ms. Belmont requested that the wording be changed to "Get Conditional Certificate" rather then "Get Temporary License" on the Edit New Information page. Ms. Blosser informed the Board that 13 on-line renewals (\$665.00) have been done since the start of the program on September 8th, 2003. There have been 55 (\$3,020.00) total from on-line and credit cards processed in the office since May when credit cards were first excepted.

Old Business: Mr. Bowyer informed the Board that we have issued 2 Podiatry License.

New Business: Mr. Bowyer discussed information on a Technology Security Policy required by the Governor's Office of Technology. Ms. Belmont made a motion to accept a draft on Security Policy presented by Mr. Bowyer to comply with the Governor's Office of Technology. Dr. Dameron seconded the motion. Motion carried.

Auditor's Meeting of September 10, 2003, was attended by Mr. Bowyer and Ms. Peters.

Mr. Greg Skinner has replaced Ms. Christy Utt as our new attorney.

WVSRT Meeting will be held on October 2, and 3, 2003. Mr. Wilcox, Ms. Belmont, and Ms. Bellomy will attend. A table will be set up to distribute the rules and regulations and to answer any questions.

Ms. Belmont requested the Board to re-examine the Temporary Provisional License definition approved by the Board in 2001. After extensive discussion Mr. Bowyer made a recommendation to keep the Provisional License, but put a sliding scale on the provisions. If license lapsed over 2 years, 24 hours of CE's or take and pass either the ARRT or state exam before they can get a license. If license has lapsed between 1 to 2 years 24 hours of CE's in 120 days, If lapsed between 6 months to 1 year 12 hours in 60 days, if lapsed less than 6 months pay reinstatement fee and re-license. An addition for military persons called to active duty was to be included for a provisional license giving them the amount of time on active duty to secure their CE's. Ms. Bellomy made a motion to continue discussion at the December meeting to require active ARRT for all licensee's except grandfather licensee's, and to continue offering a Temporary Provisional License with the sliding scale recommended by Mr. Bowyer. Ms. Morris seconded. Motion Carried.

Ms. Bellomy suggested a meal be served at the December meeting.

The Meeting was adjourned at 7:40 P.M.

The meeting was called to order by Chairman, Mark Wilcox, at 6:00 P.M..

Minutes: Ms. Bellomy made a motion to accept the minutes of September 23, 2003 as presented. Dr. Reesman seconded the motion. Motion carried.

Financial Report: The financial report was presented by Ms. Blosser. Ms. Blosser informed the Board if they request a dinner before the meetings a motion would need to be in the minutes so it can be included in the budget. Ms. Bellomy made a motion to have one (1) dinner meeting per year before the Board meeting. Ms. Belmont seconded the motion. Motion carried. Ms. Belmont made a motion to accept the financial report as presented. Ms. Morris seconded the motion. Motion carried.

Complaints: (1)Technologist that had her ARRT card revoked for altering her card has signed a consent agreement with the Board. Her license will be suspended for a three (3) year period.

- (2)Response from Cath Labs: Mr. Bowyer informed the board of the response he received from the two Cath Labs he had written concerning the use of CV techs manipulating the equipment. Mr. Bowyer felt these letters to be unacceptable and asked that a letter be sent by the Board Chairman explaining the definition of Radiologic Technology. Mr. Wilcox explained that since he has been on the Board, there has not been any specific definition for anyone to follow. Mr. Wilcox appointed a committee consisting of Ms. Belmont, Ms. Bellomy, Dr. Reesman, Dr. Schreiman, and himself, to research and adopt specific definitions for the manipulation of the equipment, technical factors, making of an exposure, and the positioning of the patient. The Committee will meet after the holidays to set up a complete definition. A letter will be sent to the Cath Labs after the definitions are in place.
- (3) Tech's Misdemeanor Conviction for Drugs: A Certified letter was sent to the Tech, who signed for it on November 22, 2003. He has 30 days to respond, or he would waive his right to respond, and we would have to set up a hearing.

4) Physician Requiring LPN to do Bone Densitometry: An LPN called to say the Doctor was requiring her to do Bone Densitometry exams. Mr. Bowyer, the LPN Board, and our attorney Greg Skinner wrote letters to the nurse informing her that the operation of x-ray equipment without being licensed by our office is against the law in WV. We have received a call from the LPN that the Doctor has hired a technologist three days a week to do the Bone Densitometry exams. Complaint Dismissed.

Ethics Rule: Ethics Rule was passed and put into effect on 11/28/03. The Ethic Rule is on the Web page.

Schools: (1) Washburn University: Our Attorney Mr. Skinner informed the Board the way the law is written the Board does not have any jurisdiction over them.

(2) Mountain State Site Visit: Mr. Bowyer informed the Board that the site visit for Mountain State went very well, they had two (2) deficiencies. They did not have any graduate surveys or employer surveys because of being a new program.

(3)RT to RTT Program at Southern: Mr. Bowyer informed the Board that Ms. Mary Holder of Southern WV Community & Technical College called and informed him that Southern wanted to start an RT to RTT program. Ms. Holder wanted to know if they have to be accredited by JRCERT or if they could just be regional accreditation. The Board instructed Mr. Bowyer to send a letter to Ms. Holder informing her that this has been discussed before and that the program would have to be JRCERT accredited.

(4) Accreditation Status: (1) University of Charleston: Increased to 5 years.

(2) St. Mary's put on probation.

New Business: Pet/CT: Dr. Dameron had questions concerning Pet/CT but was not present at the meeting. The Board recommended that it be discussed at a future meeting when Dr. Dameron is present.

Glora Crouch resigned her position with the WV Department of Health and Human Resources, Bureau for Public Health, which means she must resign from the Board. The Board will recommend Jamie Browning from the Department of Health and Human Resources to replace Ms. Crouch.

Mr. Bowyer presented a letter that Dr. Schreiman had received from Dr. Robert Smith, of the WV State Radiology Society concerning Radiologist Assistant. Mr. Wilcox will call Dr. Smith to find out the concerns and objectives of the letter and report his findings at the next Board meeting.

March meeting will be held on Thursday, March 25, 2004 at Elkview.

The meeting was called to order by Chairman Mark Wilcox, at 5:05 P.M.. Mr. Wilcox welcomed new Board member Jamie Browning as the representative of the West Virginia Department of Health and Human Resources, Bureau for Public Health.

Minutes: Ms. Bellomy made a motion to accept the minutes of December 2, 2003 as presented. Ms. Belmont seconded the motion. Motion carried.

Financial Report: The financial report was presented by Ms. Blosser. Ms. Bellomy questioned the excessive postage expenditure in February. Ms. Blosser informed her this was for the mass mailing of the newsletter. Ms. Bellomy asked if we need to send out newsletters or could we just put them on the web page. Ms. Browning made a motion to accept the financial report as presented. Ms. Bellomy seconded the motion. Motion carried.

Complaints: (A) Misdemeanor convictions - Tech had multiple misdemeanor convictions in Putnam county. Technologist surrender license to office. Case dismissed.

(B) Technologist practicing medicine without a license - A nurse made a complaint against a Technologist for receiving prescription medication from a physician and distributing to a third person. Our Attorney Mr. Skinner drafted a letter to the Technologist. The Technologist responded with a letter and copies of x-ray results, doctor's findings, and insurance information to confirm that the prescription medication was for her personal use. The Ethic's committee, and Mr. Skinner has reviewed the information and recommends the charges be dismissed as unfounded. Ms. Belmont made a motion to accept the recommendation of the Ethic's's Committee to dismiss the complaint. Ms. Browning seconded the motion. Motion carried.

Ms. Belmont made a motion to forward information back to the RN Board concerning the frivolous complaint made against the Technologist on the recommendation of Mr. Skinner. Ms. Browning seconded the motion. Motion carried. Mr. Bowyer will send a letter to the Technologist advising of the dismissal of the charges.

Interpretative Ruling: A Committee appointed by Mr. Wilcox met and drafted an Interpretative Ruling Definition of Radiologic Technology to present to the Board. After a lengthy discussion, the Board with recommendations from Mr. Skinner made specific changes to the draft. Mr. Skinner advised the Board that the definition should now be implemented into the Code of State Rules, which could be done by interpretive rule. Ms. Browning made a motion to accept the Interpretative Ruling Definition of Radiologic Technology with the changes and additions made by the Board. Ms. Bellomy seconded the motion. Motion carried.

The Board requested Mr. Bowyer start the process to have the Interpretative Ruling Definition of Radiologic Technology implemented into the Code of State Rules by interpretive rule.

Legislation: Series 1 - Mr. Bowyer advised the Board of changes needed in Series 1 rules. Most are additional or changing of wording. Mr. Bowyer informed the Board that an increase of some fees is needed at the present time in order to curtail the ever increasing expenses. Ms. Blosser gave a report of the increase of running the office for last year and the increases known for the coming year. After a lengthy discussion the Board decided to increase all fees except the renewal fee at this time. Ms. Bellomy suggested that a notice be put on the web page of a possible increase in renewal fees at a future date, with an explanation as to why the fees need to be increased (i.e. - increase in office operations, fees lost in credit card transactions, unfunded mandates, etc.).

Ms. Belmont made a motion to move forward with the filing of Series 1 with the increased fees included for the 2004 deadline. Ms. Bellomy seconded the motion. Motion carried.

Appointments: Mr. Bowyer advised the Board that Dr. Schreiman resigned from the Board. Dr. Dameron has also informed Mr. Bowyer that because of his work schedule he will have to resign form the Board. Mr. Bowyer informed the Board that Dr. Elaine Moore expressed interest in being appointed a Board member to replace Dr. Schreiman, and that Dr. Reesman had recommended Dr. Terry Shank to replace Dr. Dameron. Dr. Shank will be approached concerning an appointment to the Board. Ms. Belmont and Ms. Browning have expressed their desire to be reappointed at the completion of their terms. Mr. Bowyer will send a letter to the Governor of the reappointments and the possible appointments to the Board.

Radiology Assistant: Dr. Robert Smith, who was to attend the meeting could not attend. Discussion tabled to a future time when Dr. Smith can attend.

Old Business: Credit Cards - 28% have been done on line since July.

New Business: Possible Lawsuit: A possible lawsuit being served against the office was discussed. An attorney in Kanawha County is possibly going to bring a lawsuit against all Boards not in the city limits of Charleston. Mr. Skinner advised the Board that a lawsuit has not been started because everyone is waiting to see the out come of the current law suit against the Lottery Board moving from the city limits of Charleston.

Web Page - Mr. Bowyer informed the Board the web page is being redone and should be in place shortly. The new web page will also include a "Frequently Asked Question" section, and a "Complaint Form" for anyone with a complaint to complete and return.

Graduating Class' of 2004 - 136 will be graduating this spring from Radiologic Technology schools in West Virginia and one in Ohio.

June meeting will be held on Thursday, June 10th at Elkview.

The meeting was called to order by Secretary, Susan Bellomy, at 5:15 P.M. A quorum was not present so Ms. Bellomy asked Mr. Bowyer if he had anything to present or to discuss that would not require a vote at this time.

Legislation: Series 1 Rule - The rule was filed in April for public comment for 30 (thirty) days. No comments were received by the office during the public comment period. The Rule was filed on June 10, 2004 with the Legislative Rule Making Review Committee and the Secretary of State's Office. It should be on the interim's agenda in July at which time Mr. Bowyer will attend the meeting. The Rule will then lay until the Legislature comes into session. Mr. Bowyer advised the Board that he has been informing the schools that he has visited and the hospitals he has inspected about the Series 1 Rule increase in fees except for the renewal fees. He has also been informing them that the last increase of renewal fees was in 1998 and in 2006 or 2007, the renewal fee could be increased due to the continuing rise of inflationary costs and operational expenses of the Board.

Series 6 Rule - The rule was effective on June 10, 2004. This is the definition of the Practice of Radiologic Technology. Mr. Bowyer informed the Board that since the Series 6 Rule is now in effect, he will send a letter to all the Cath Labs with a copy of the Rule as agreed upon at the December 2nd 2003 meeting.

Complaint: (A) Dental personnel taking hand x-rays - The office was contacted about a Dental Office in Beckley taking hand and wrist x-rays for bone growth by the Dental Assistant and Hygienist. The Board has no jurisdiction over the Dental Assistant or Hygienist, so Mr. Bowyer forwarded the complaint to John Parklo with the Dental Board. The response from the doctor from Mr. Parklo's correspondence was that this was common practice in an Orthodontic Dental Office's and sent documentation to this effect. The response did not include that only the doctor himself, who is exempt from our law, took the x-rays. Mr. Bowyer will discuss this further with Mr. Parklo that unless the Doctor himself takes the x-rays, this is not acceptable to this Board. The Dental Assistant and Hygienist can not take the x-rays without having a license with our office. The Dental Board will have a meeting in July to discuss this matter.

Old Business: All the books were delivered to the graduating class of the schools. Sixty-three (63) temporary license have been issued at this time, with approximately sixty-eight (68) left to graduate. Out of those issued, nineteen (19) have passed their ARRT exam and one has failed.

License inspections: All of the hospitals in the state have now been inspected at least once.

Reappointments: A letter has been submitted to the Governor for reappointment to the Board for Alice Belmont and Jamie Browning. A replacement must be appointed for Dr. Dameron who's term expires on June 30, 2004.

Auditor's Seminar: The seminar will be held on September 8th, 2004. It was recommended that Ms. Browning, being a new member, would benefit by attending the seminar with Mr. Bowyer. Mr. Bowyer will contact Ms. Browning's supervisor for permission for her to attend the seminar with Mr. Bowyer.

A request was received by the office from Ms. Chris Paugh, Program Director at WVU Hospital Radiation Therapy school to have Radiation Therapist's license a different color from the Radiologic Technologist's license. After a discussion, the Board's consensus was that they did not see a need or a purpose at this time to have the color changed. This is primarily due to the fact that if the Board changed the color for therapists, it would also have to change the color for all the other radiology specialities.

Mr. Bowyer contacted Dr. Moore for a conference call to have a quorum.

Minutes: Ms. Bellomy made a motion to accept the minutes of March 25, 2004 as presented. Ms. Browning seconded the motion. Motion carried.

Financial Report: The financial report was presented by Ms. Blosser. Ms. Bellomy made a motion to accept the financial report as presented. Ms. Belmont seconded the motion. Motion carried.

Personnel Evaluations: Ms. Bellomy presented the evaluation that Mr. Wilcox had completed on Mr. Bowyer with the recommendation of a 4% (four percent) pay increase. Mr. Bowyer recommended a 5% (five percent) pay increase for Ms. Blosser. Mr. Bowyer recommended that the Board give Ms. Casto, our temporary clerical help, a raise of \$1.00 per hour pay increase. Ms. Bellomy stated for the record that the Board appreciates the effort, the work and the fine job done by Mr. Bowyer and Ms. Blosser. Ms. Bellomy made a motion that Mr. Bowyer received a 4% (four percent) pay increase, Ms. Blosser receive a 5% (five percent) pay increase and Ms. Casto a \$1.00 an hour pay increase. The meeting was called to order by Dr. Moore, Chairperson, at 5:15 P.M. Mr. Bowyer welcomed new Board members Dr. Moore and Dr. Baek and extended a welcome to the Nuclear Medicine guest.

Minutes: Dr. Baek made a motion to accept the minutes of June 10, 2004 as presented. Ms. Bellomy seconded the motion. Motion carried.

Financial Report: The financial report including the credit card expenditures was presented by Ms. Blosser. Ms. Belmont made a motion to accept the financial report and credit card expenditures as presented. Ms. Morris seconded the motion. Motion carried.

Old Business: PET/CT- Dr. Moore requested that a discussion on operation of PET/CT be the first order of business since our Nuclear Medicine guest were most interested in this matter. Mr. Wilcox stated that as the present law is written, an individual must have graduated from an accredited program in Radiologic Technology and pass a written examination approved by the Board and be licensed by this Board, or they are not eligible to operate the PET/CT units. Mr. Wilcox asked the Nuclear Medicine guest for their input into this matter. After a lengthy discussion the Board advised Mr. Wilson, spoke person for the Nuclear Medicine guest, that the Board was supportive of a change to add Nuclear Medicine to our Code and would be willing to work with the Nuclear Medicine Community to seek legislation amending this portion of the law or adding a new section to deal with this issue. A recommendation by the Nuclear Medicine community would have to be written and submitted to the Board for their consideration. The Board would consider the recommendations and if approved seek the appropriate changes before the Legislature. The earliest any changes of this kind could be made to the Code would be in the 2006 Legislative session. The Board cautioned Mr. Wilson however, that any type of legislation would have to include the entire Nuclear Medicine community within the State, not just a select group to operate the PET/CT Units. The Board asked Mr. Bowyer to send a letter to all facilities with PET/CT units advising them of

the Law as presently written and stating the position of the Board at this time concerning who can use PET/CT units.

Legislation: Series 1 Rule for 2005- Submitted to the Secretary of State and Legislative Rule Making Review Committee. It has gone through the Committee without any questions, and it will now be introduced around the end of February to the Legislature. This is the rule increasing all the fees except the annual renewals.

Series 1 Rule for 2006 - Mr. Bowyer informed the Board that even with the increase of fees in the Series 1 Rule for 2005, an increase in the annual renewal fee needs to be addressed at this time, or the Board could be insolvent in three (3) years because of the dwindling number of technologist renewing their licenses and the ever increasing cost of maintaining the office. Following a discussion as to an amount to raise the fee, Dr Baek made a motion to increase the annual renewal fee \$15.00, making a total of \$65.00 for the annual renewal fee. Ms. Bellomy seconded the motion. Motion carried.

The Board asked Mr. Bowyer to draft a memo for the web page advising the Technologists of the Board's decision and reasons for the needed increase to the annual renewal fee to be submitted to the Legislatures for the 2006 session. - (E) Drug Testing Results on Suspended License Individual's license was suspended on October 2003 for three (3) years during which time random drug testing were to be administered as per a Consent Agreement. Drug test results were fine and the individual is living up to the Consent Agreement.

Mr. Bowyer presented a letter received from an individual seeking to apply for a license. The Individual stated she was dismissed from her position in New Mexico for stealing drugs. Her license with ARRT was revoked until January 2006. She stated that she has successfully completed her probation, and has completed drug rehab, and would like to get a license in the state of West Virginia. Mr. Bowyer sent a letter to the individual requesting further information, which he did not receive at this time. After a discussion on the matter, Mr. Wilcox made a motion to table the discussion until the March meeting in order to receive the requested information. Dr. Reesman seconded the motion. Old Business: (A) Collins Career Center - Mr. Bowyer received a letter from Collins requesting recognition of their RT program. Mr. Bowyer advised them they had to be JRCERT accredited or equivalent. Mr. Bowyer was informed that Collins had in fact submitted an application to JRCERT. Mr. Bowyer was told by JRCERT that Collins had applied, but had also withdrew the application. The meeting was called to order by Dr. Moore, Chairperson, at 5:20 P.M.

Minutes: Mr. Wilcox made a motion to accept the minutes of December 2, 2004 as presented. Ms. Bellomy seconded the motion. Motion carried

Financial Report: The financial report including the credit card expenditures and procedures were presented by Mr. Bowyer. Dr. Moore and Ms. Peters gave a report on their examination of the financial information of the Board. Dr. Moore and Ms. Peters determined that there were not any more significant cuts in the budget that could be made at this time. Ms. Blosser was commended for her written presentation. Mr. Wilcox made a motion to accept the financial reports and credit card information as presented. Ms. Browning seconded the motion. Motion carried.

Complaints: A report was given by Mr. Bowyer on the status of the active complaints as follows:

- (A) Dismissal for Failure of Drug Screen for Cause A hearing was held on February 8, 2005, before a hearing examiner. Attorney Skinner stated that, since she did not appear or send a representative, the Board's evidence was entered into the record. The hearing examiner will be issuing his report on or before March 31, 2005. Attorney Skinner stated that the Board could accept, reject or modify the hearing examiners recommendation.
- (B) Dental Personnel Taking Hand X-rays Attorney Skinner has been in contact with the Dental Board's Attorney concerning this practice. The Dental Board had a meeting on December 4, 2004 to discuss this issue but failed to do so. Attorney Skinner has explained our Board's position on this matter and stated that the Dental Board's attorney as well as their Executive Director has concurred with our Board's position. The Dental Board will be meeting during March, 2005 and assurance has been given that this matter will be on their agenda for discussion.
 - (C) Forging Prescriptions Still Pending. This case has not gone before the Circuit Court.

(D) RN operating C-arm fluoroscopic unit in surgery: Administrator of facility verbally acknowledged this was done. He stated the RN was disciplined and the use of a c-arm protocol for the OR procedure has been changed to prevent a re-occurrence. A written response will be submitted to the Board's office. Upon receipt of written response, a letter will be sent to the RN Board for possible disciplinary action against the RN for working outside the scope of practice.

Legislative Update: The Series 1 Rule was introduced in the Legislature on February 28, 2005 (SB 380 & HB 2747). The Senate Bill has been referred to their Finance & Judiciary Committees while the House version has been referred to their Government Organization and Judiciary Committees. A request has been made for a representative from our Board to appear before the House's Government Organization Committee on Monday, March 7, 2005 to answer any questions the Committee may have. The Rules for the 2006 Legislative Session must be filed with the Secretary of State's office and the Legislative Rule Making Review Committee by close of business on July 29, 2005 after going through the thirty (30) day comment period.

Old Business: (A) Individual requesting temporary permit / license - A discussion was continued from the December 2, 2004 meeting concerning this request. After a lengthy discussion and examination of the material submitted by the individual, the Board feels an attempt is sincerely being made to straighten out the past. It was pointed out that the request was for a temporary permit, however, a temporary permit cannot be issued for someone that has been out of a School of Radiologic Technology for greater than six (6) months. A letter will be sent stating that, before consideration of receiving a license, the individual must pass a written examination. This can be either the ARRT examination or the Board's examination. Once the individual has successfully passed the written examination, the Board can and will consider this request. Without successful passage of the written examination, this matter becomes a moot point.

(B) Collins Career Center - Mr. Bowyer received information that this school has re- applied to the JRCERT for accreditation in December, 2004. As discussed, our law states that a school "shall follow the current standards as established by the JRCERT". It was decided a letter will be sent to Collins Career pointing out the law and that the Board does not have statutory authority to "recognize" a school. Once full accredition has been achieved, the students will be eligible for temporary permits upon graduation.

(C) Nuclear Medicine Technologists - Lori Williamson with the Appalachian Association of Nuclear Medicine Technologists gave a report on the recent polling of the state's nuclear medicine community concerning the issue of licensure. Around 180 questionnaires had been sent with response received from 74 individuals. There were 71 "yes" responses to having a licensure for nuclear medicine, 2 "no" responses with 2 individuals asking questions without a response. A meeting has been scheduled between the Board's committee and the Nuclear Medicine's committee to begin the formulation of proposed legislation.

New Business: Ms. Bellomy requested that the Board make an effort to obtain licensees' e-mail addresses and send information to them via this method in the future (such as newsletters). It was pointed out that there is a space on the application form for the licensee's email address and optional (cell) phone number. Whenever this information is submitted, it is entered into the database. Ms.

Bellomy also requested the Board conduct a marketplace research project to obtain information on the cost of licenses of other state Boards, and also obtain the same information from other states with RT licensure. It was pointed out that the technologist information was available for the states on the ARRT or ASRT web sites. The information on the in-state Boards will be gathered and distributed to the Board members.

Mr. Wilcox stated that he had been in contact with Dr. Robert Smith concerning the issue of Radiology Assistants (RA). Mr. Wilcox explained to Dr. Smith that our law would cover the licensure of RA's, since these individuals would have to be licensed through our Board. Dr. Smith stated that Dr. Cordell with the Medical Association would need to talk to Mr. Wilcox or the Board since the Medical Association may attempt to seek legislation to license the RA's in-state. Mr. Wilcox requested Mr. Bowyer to monitor legislation being introduced and inform the Board if anything pertaining to the RA's is introduced.

The next meeting of the Board will be held on June 9, 2005 at 5:00 p.m. at One Davis Square in Charleston.

The meeting was called to order by Dr. Moore, Chairman, at 5:00 P.M.

Minutes: Ms. Bellomy made a motion to accept the minutes of March 3, 2005 as presented. Mr. Wilcox seconded the motion. Motion carried.

Financial Report: The financial report including the credit card expenditures were presented by Ms. Blosser. Mr. Bowyer informed the Board that the travel expense for the Board members would now be presented for payment after the June and December Board meetings. Mr. Wilcox made a motion to accept the financial report and credit card expenditures as presented. Ms. Bellomy seconded the motion. Motion carried.

Complaints: (A) Dismissal for Failure of Drug Screen for Cause - Mr. Wilcox made a motion to accept the findings of Hearing Examiner Jack McClung dated May 24, 2005 in its entirety, and to have Mr. Skinner send a letter to the Tech of the decision of the Board. Ms. Browning seconded the motion. Motion carried.

- (B) Dental Personnel Taking Hand X-Rays Mr. Skinner advised the Board that our law does prohibit the taking of hand x-rays by non licensed individuals, and that he has been working with the Dental Board's Attorney but a solution has not been forthcoming. The Board asked Mr. Skinner to send a letter to the Dental Board advising them of our law and possible legal action if our law is not adhered to. The Board tabled further discussion of this matter to the next meeting pending a reply to Mr. Skinner's letter.
- (C) Forging Prescriptions The Board made a decision to have the individual meet with are Ethics Committee, comprised of Ms. Browning, Dr. Reesman, and Dr. Moore. Mr. Bowyer will send a letter to the individual informing him of the meeting and asking for all pertinent information concerning his case. This matter was tabled to the next Board Meeting to give the Ethics Committee time to meet with the individual and to report back to the Board of their findings. Mr. Skinner was asked by the Committee to also attend the meeting.

- (D) RN Taking X-rays Letter sent to the RN Board concerning the nurse. RN Board investigating.
- (E) Renewal of License The office received a letter for renewal of an individuals license who has indicated he has committed a felony. The Board asked Mr. Bowyer to send a letter to the individual asking for further information. Matter tabled till next meeting to receive the information.

Legislation Update: Series 1 Rule was implemented on June 1st, 2005. Series 5 rule must be filed with the Secretary of States Office and the Legislative Rule Making Review Committee by close of Business on July 29, 2005 after a thirty (30) day comment period. Dr. Reesman made a motion to submit the Series 5 Rule for public comment and send copies to all Board Members for any possible changes before submitting to the Secretary of State Office and the Legislative Rule Making Review Committee on July 29, 2005. Mr. Wilcox seconded the motion. Motion Carried.

Old Business: Nuclear Medicine Technologists being added to our present law. Mr. Wilcox and Mr. Bowyer met with Brenda Thompson, chief legal counsel with the WV House of Delegates Government Organization Committee and Steve Thompson, legal analyst with the committee concerning adding Nuclear Medicine Technologists to our present law. Ms. Thompson and Mr. Thompson explained that it would not be legal to just add the Nuclear Medicine Technologists to our law. In order to include any new profession to our law it would have to go through a study (Sunrise Law) conducted by the legislature to see if it is warranted to protect the public's health and safety. Mr. Bowyer explained that before this study is conducted, the Legislative Committee on Government Organizations's study questionnaire must be submitted along with documentation from various sources by December 1st. The study would begin at that point and continue until the following December when an interim report would be prepared and presented to the Legislature. This would enable legislation to be formulated from the report and a bill prepared for introduction. The earliest any legislation to add other disciplines to our law would be the 2007 session. After a discussion concerning this matter, Dr. Reesman made a motion to include all 6 disciplines not just Nuclear Medicine Technologists and RPA's. Mr. Wilcox seconded the motion. Motion Carried.

New Business: RPA Letter - Mr. Bowyer informed the Board that he received a letter from an individual concerning the permissible scope of practice of Radiologic Technology as it pertains to the Radiology Practitioner Assistant program. The individual has an active license from the office, and is participating in the RPA program through Weber State University in the capacity of a student. After a discussion the Board advised Mr. Bowyer to send a letter to the individual informing her that it does not appear that she is acting in violation of any rule or regulation of the Board.

Personnel Evaluations - Mr. Bowyer presented the evaluation for Ms. Blosser and informed the Board that the results of the evaluation was a recommendation of 4% pay increase per the Boards evaluation percent of raises approved on October, 2001. Mr. Bowyer asked the Board to approve the 4% with 2% going into effect in July and waiting to see what the Governor's recommendation for raises for all state employees would be in September. If the Governor does not give all state employees a raise the other 2% would go into effect in October. Dr. Moore did not have Mr. Bowyer's evaluation with her, but informed the other Board members she would email the results to them the next day and they could vote on his pay increase at that time.
