**AMENDED FINAL ADMINISTRATIVE ORDER**

Upon review of the record in the above-styled matter, the West Virginia Medical Imaging and Radiation Therapy Technology Board of Examiners (hereinafter "Board") hereby **ADOPTS**, in its entirety, the Hearing Examiner's Recommended Decision, dated February 1, 2011, which is attached hereto and incorporated by reference herein. Based on the Hearing Examiner's Findings of Fact and Conclusions of Law, the Board hereby **ORDERS** as follows:

1. That the Respondent's license is **SUSPENDED for five (5) years**;
2. That the Respondent shall pay to the Board its administrative costs and legal fees associated with this proceeding within thirty (30) days of the entry date of this ORDER, or a payment plan agreed to by the Board and Respondent, which total \$ 2,884.00;
3. That the Respondent shall be reinstated in good standing with the American

Registry of Radiologic Technologists (ARRT), and

4. That if upon successful completion of this five year suspension, the Respondent may then make application for reinstatement for licensure.

- 3.  PAYMENT OF \$ 1,442.00 WITHIN THIRTY (30) DAYS OF SIGNING OF THIS AGREEMENT AND THE REMAINING BALANCE IN FIVE (5) MONTHLY INSTALLMENT PAYMENTS OF \$ 240.33 AND A FINAL PAYMENT IN MONTH SIX OF \$ 240.35, BEGINNING WITHIN THIRTY (30) DAYS OF SIGNING OF THIS AGREEMENT.
